WINDSHIELD CHIP REPAIRS:

A windshield chip or bruise is repaired to preserve as much as possible the original strength of your windshield. Repairing your windshield chips will also prevent future cracks from spreading outwards from them. Upon being repaired the bruise on your windshield will become less visible but it will not disappear altogether. In a very limited number of repairs, the initial bruise or crack may spread out further during the repair process and we cannot claim responsibility for that occurrence. However, in such instances you will not be expected to pay for the attempted repair. Once a repair is complete, Brite-View Glass warranties that repair to hold for as long as you own the vehicle. In the rare event that the repair does spread out at a later date, Brite-View Glass will either attempt a second repair at no charge to you, refund to you the money you spent on the initial repair, or credit that same amount towards a new fleet-priced windshield replacement at Brite-View Glass. This repair warranty is non-transferable.

AUTO GLASS REPLACEMENTS:

BRITE-VIEW GLASS makes every effort to approach each job we are given in a professional manner. In addition, we also make every effort to supply you with the highest quality auto glass parts and auto glass sealants available.

BRITE-VIEW GLASS offers a lifetime warranty against defective workmanship on all its auto glass installations with some limitations. Limitations that will limit or void this lifetime warranty include the following: installation of used parts, warranty issues resulting from existing or subsequent rust damage on the vehicle, gasket or moulding deterioration, instances where subsequent repairs were attempted or additional work was performed by a third party, instances where the installation has been abused, misused or improperly maintained, instances where subsequent structural changes to the body of the vehicle have occurred, and instances where there is a failure to report to our staff a possible warranty issue within a reasonable time frame from the date of the original installation. This warranty is non-transferable.

On Auto Glass parts, BRITE-VIEW GLASS will warranty any new windshield it supplies to you against stress breakage and distortion for a period of 90 days from the date of supply. There is no manufacturer's warranty on new tempered auto glass parts or on used parts of any sort. Consequently, Brite-View Glass cannot warranty these items.

On auto glass parts that require a non-warranty removal and subsequent reinstallation of the <u>same</u> (commonly referred to as an R&R), BRITE-VIEW GLASS offers no warranty against damage to or breakage of such during the removal and/or reinstallation process. In the event of breakage BRITE-VIEW GLASS will supply a like-kind-and-quality-part at competitive market rates, and solely as a gesture of goodwill waive the labour costs associated with its installation.

BRITE-VIEW GLASS reserves the right to inspect all products and installations prior to authorizing any warranty claim for repair or replacement. All warranty work must be done at a location approved by Brite-View Glass management.
